Minutes from the September 20, 2012 meeting were reviewed. Correction given was the date of the next meeting should have been listed as October 18, 2012. Dale Wise moved and Denise McConkay 2nd to accept the minutes as corrected. Approved as corrected.

Pastor Neil gave the Devotional which focused on Luke 21:1-4—The widow giving all she had appeared little in the eyes of the world but great in the eyes of God. Jesus gave His life for you, are you ready to give your life for Him? Are you ready to listen to God's call to give of your talents, time and treasures? The call to worship Him is often the call to "impulsiveness"—in giving to others and to God.

Weekend Reports

Men's Weekend—Kerwin Knudson

- Suggested giving people more time to plan, build teams, and write Rollos (knowing many procrastinate until the last minute in writing Rollos)
- Deaf Weekender, Don Christy—Changed him! Kim Russell interpreted Thursday night and all day Saturday. Kim reported deaf people are often treated as the Black people were in the 60's. May want to check with Don to see if he would be interested in being a spokesperson to/for the deaf community and Utah VDC as our mission field may be increasing! Yeah God!
- Dave Morse has asked Kim Russell to write a report on serving and areas to improve.
 Brick Thompson suggested having Kim and Don be invited to attend a VDC Secretariat meeting
- One weekender got sick and missed most of the Friday and Saturday Rollos but was very moved by the Agape Dinner—Kneeled and prayed at Jesus' chair (God's working in mysterious ways being very evident)
- Men's Rollistas requested unusual items—One requested a Thanksgiving Meal which the Kitchen Team interpreted as Thanksgiving Dinner (which they provided). In talking with this Rollista, Kerwin discovered this Rollista meant a meal of Thanksgiving and not necessarily a Thanksgiving Dinner. Anne Pritchard helped with the "English Breakfast" request

- Kerwin stated "It will take me 6 months to get over the VDC Overload"—His excitement regarding the Weekend was so intense

<u>Women's Weekend—(Carolyn Drain unable to attend), Neil Arnold, Anne Pritchard, Annie Layton, Ruth Hanzlik and Kelly Martin</u>

- Neil reported 2 weekenders were asked to leave (mother and daughter) due to
 extenuating circumstances which complicated the weekend for other Weekenders,
 Table Leaders, Rollo Room Leadership and which had possibility of putting GSLC at risk.
 One Table Leader did not feel able to give Rollo nor did she feel adequately equipped to
 be a Table Leader. Another table suffered the sense of loss and brokenness due to one
 of the two weekenders leaving. Members of the Weekend Leadership Team
 experienced a sense of fragmentation as a result of the various activities and decisions
 made due to this complicated situation. However, the remaining 10 Women
 Weekenders felt strongly blessed by the weekend overall, as reported by them at the
 Clausura
- Two of the Angels for the Weekend showed up in an incapacitated state, but were allowed to participate as it was felt their conditions would not affect the Weekenders based on the roles they were assuming at the time. Begs the question, "What to do in the future with similar situations?" <u>Definitely need to remind everyone, Team</u> <u>Members and Angels of ALL OF THE POLICIES AND PROCEDURES OF THE VDC</u> <u>WEEKENDS!</u>
- Several instances of people (Team members, Angels)—Attempting to take over responsibilities and/or decisions which were not theirs to do/decide. Anne Pritchard suggested the Resource Person for each Team should describe the roles of Team Members and continue to be available via email/phone calls to answer any questions or concerns
- Rector/a for the Weekends should feel comfortable with being able to call on the Trainer for the weekends as the need arises
- Assistant Rector/as need to keep the weekends running on time as much as possible
- Communication with each other, as well as prayer, are the keys to overall unity and peace within each Team and the Weekend Team as a Whole!!!
- Anne will be adjusting the amount of food to buy for the weekends to reflect 60 versus 100 people at this time due to the fact that we are limited in space and number of people involved/weekend
- May need to consider increasing weekend fee—We currently charge the lowest amount. Light in the Desert (Las Vegas) charges \$125/Team Members and \$25/Weekender as reported by Brick Thompson
- Inventory of all items (amount and location) completed by both the Men's and Women's Weekend Teams
- Suggested VDC Secretariat promote the weekends at the affiliated churches to help keep the VDC Community alert to upcoming weekends and praying for guidance in the invitations given to possible weekenders. Roles of Sponsors should be more clearly stated as well as the fact that the VDC weekends are designed for established Christians

"to experience the love and grace of God, to know Christ personally and to be enabled by the spiritual renewal to live a balanced Christian life and demonstrate the power of love at work in their environment." This is a direct quote from the Mission Statement of the VDC Organization
